Governing Law & Venue:

1) Purpose

Client will share project information so Teplaron can perform thermal design, sizing, quotation, and feasibility. Information is used only for this purpose.

2) Confidential Information

All non-public information shared in any form, including drawings (P&ID, GA, layout), models (STEP/IGES), datasheets, specifications, process data, photos/videos, site details, pricing, client lists, contracts, emails, and notes. **Exclusions:** a) public information; b) known to Recipient before receipt; c) independently developed with evidence; d) disclosure required by law/regulator (Recipient will give prompt notice when permitted).

3) Use & Protection

Recipient will use the information only for the Purpose; protect it with reasonable care (no less than for its own similar information); share only on a need-to-know basis with employees or approved subcontractors under equal NDA; and not reverse engineer or de-identify to avoid obligations.

4) Data Security

Store on controlled systems with role-based access; use encrypted transfer where possible; keep audit logs for access and downloads; report any suspected breach within 72 hours.

5) Ownership & No License

All confidential information remains Client's property. No license is granted except internal evaluation for the Purpose.

6) Retention & Return

Upon request or completion of the Purpose, Recipient will return or securely destroy confidential information, except one archival copy for legal compliance. Standard retention: 24 months, unless law or the project requires longer.

7) Term

This NDA lasts 5 years from the Effective Date; trade secrets remain protected as long as they qualify.

8) Compliance

Both parties will comply with applicable laws, including export controls and sanctions. Client confirms it has the right to disclose the information.

9) Remedies

Unauthorized disclosure may cause irreparable harm. Client may seek injunctive relief in addition to other remedies.

10) Miscellaneous

No partnership or exclusivity is created. This is the entire agreement; amendments must be in writing. Governing law & venue: [____]. This NDA may be signed electronically and in counterparts. Notices: [emails/addresses of both parties].
